NOTICE OF RACE**

**1 ORGANISING AUTHORITY**

The Organising Authority (OA) is the Royal Port Nicholson Yacht Club (RPNYC).

**2 VENUE**

The venue will be the Wellington Harbour adjacent to Oriental Bay, Wellington, New Zealand.

**3 EVENT GRADING**

The event is a World Sailing (WS) Grade 3 event.

This grading is subject to review by the WS Match Racing Advisory Board. The event may be re-graded when there is clear reason to do so.

**4 SKIPPERS ELIGIBILITY**

- (a) Eight teams will be invited to participate in the event. Only skippers invited by the OA will be eligible to enter this event.
- (b) Skippers wishing to enter should register their interest with the OA by completing the online application by 1700hrs on 8 December 2018. Late applications will be accepted at the discretion of the OA.
- (c) To remain eligible a skipper shall confirm acceptance of invitation in writing (email is acceptable) to be received by the date specified on the letter of invitation.
- (d) The registered skipper shall helm the boat at all times while racing, except in an emergency.
- (e) All competitors shall meet the eligibility requirements of WS regulation 19.2.
- (f) All competitors must not have reached their 23<sup>rd</sup> birthday on or before 17 February 2019.
- (g) All competitors shall have a WS Sailor ID (obtained by registering online at [www.sailing.org/isafsailor](http://www.sailing.org/isafsailor)). Skippers shall inform OA of their WS Sailor ID at registration.

## 5 ENTRIES

- 5.1 Entries will only be accepted from invited skippers. If you wish to be invited please register your interest in receiving an invitation by completing and returning the application for invitation form to the OA by 8 December 2018. Confirmation of invitation to the event will be sent to invited teams by 15 December 2018. All invited teams are required to confirm their acceptance of their invitation by 1700hrs Sunday 14<sup>th</sup> January 2019.
- 5.2 The team shall be entered on completion of registration and the payment of all fees and deposits. All payments shall be made by credit card, bank deposit, cash or cheque.
- 5.3 **Entry Fee**  
A non-refundable entry fee of \$NZD1250 (inc GST) shall be paid by 1700hrs Sunday 14<sup>th</sup> January 2019.
- 5.4 **Damage Deposit**
- (a) An initial damage deposit of \$NZD1000 shall be paid at registration, unless extended by the OA. This deposit is the maximum payable by the team as a result of any one incident.
  - (b) In the event of a deduction from the damage deposit being made, the OA may require that the deposit be restored to its original amount before the team will be permitted to continue in the event.
  - (c) Any remaining deposit at the conclusion of the event will be refunded within 10 days of the event.
- 5.5 **Insurance**  
All competitors are required to have third party insurance.

- 6.2 Unless excused by the OA, attendance at the following is mandatory:
- (a) Initial briefing for skippers.
  - (b) Daily briefing for skippers.
  - (c) Prize giving

6.3 Schedule and Prize-giving may be amended subject to weather or time constraints.

## **7 RULES**

- (a) The event will be governed by the rules as defined in the RRS 2017-2020, including Appendix C.
- (b) The Sailing Instructions (available at registration) and any amendments.
- (c) The rules for the handling of boats will apply for the event and any practice sailing.
- (d) All sailors shall wear a personal floatation when aboard the Elliot 6 yachts and when not docked.
- (e) Class rules will not apply.

## **8 BOATS AND SAILS**

- (a) The event will be sailed in Elliot 6 Class Boat provided by the OA.
- (b) Four boats will be provided.
- (c) The following sails will be provided for each boat:  
Mainsail, jib, symmetrical spinnaker
- (d) Boats will be allocated by a draw by the Race Committee for each round robin prior to the regatta, and prior to each elimination round.

## **9 CREW (INCLUDING SKIPPER)**

- (a) The number of crew (including the skipper) shall be 3 or 4 and all shall be under 23 years of age as at 18 February 2018. All registered crew shall sail all races.
- (b) The maximum total crew weight, determined prior to racing shall be 262.5kg, when wearing at least shorts and a t-shirt.
- (c) When a registered skipper is unable to continue in the event the OA may authorise an original crewmember to substitute.
- (d) When a registered crew is unable to continue in the event the OA may authorise a substitute, temporary substitute or other adjustment.

## **10 EVENT FORMAT**

- (a) The event will consist of the following stages:
  - Stage 1- 2 Round robins
  - Stage 2- Semi Finals
  - Stage 3- Finals
- (b) The OA may change the format, terminate or eliminate any stage, when weather conditions do not permit the completion of the intended format.

## **11 COURSE**

- (a) The intended course will be windward/leeward with all marks rounding to starboard and a downwind finish.

- (b) The intended course area will be in the vicinity of Wellington Harbour adjacent to Oriental Bay, Wellington, New Zealand.
- (c) Leeward gates may be used.

**12 ADVERTISING**

- (a) Each boat may be required to display advertising as supplied by the OA.
- (b) Boats shall not be permitted the right to protest for breaches of any rules regarding advertising.

**13 PRIZES**

- (a) The principal prize for first place will be the CentrePort International Youth Match Racing Cup.
- (b) The OA may reduce a prize in the case of misconduct or refusal to comply with any reasonable request, including attendance at official functions.

**14 MEDIA, IMAGES AND SOUND**

The OA shall have the right to use any video, images and sounds recorded during the event free of charge.

**15 COACH BOATS**

- (a) Coach boats are not permitted.
- (b) A boat will be provided for coaches to be on the water during racing.

**16 ACCOMMODATION AND MEALS**

The OA will provide breakfasts and lunches to all competitors on the days that they are racing. RPNYC will endeavour to provide accommodation, if requested by national and international competitors.
